#### Unplayed match

v Gants Hill, PMT, R3 (home): Tie lost by default. Because the Maccabi Union National Football Committee failed to appoint a referee for this tie, both Temple Fortune and Gants Hill, a M(S)FL Premier League team, mutually agreed to postpone the match, having decided not to play it without a qualified neutral referee. However, the MUNFC ruled that the tie should be awarded to Gants Hill, an extremely unfair decision which would have resulted in an appeal to the Football Association but for an appalling false-hood by the MUNFC Referees Secretary. Having informed Temple Fortune that a referee would not be appointed - the very fact which prompted both teams' decision to postpone – he later denied passing this information. Temple Fortune concluded that his deception would have been very difficult to verify before the FA, hence no subsequent appeal.

The fixture v Kenton JYC on October 6 was originally played as a League fixture. Kenton JYC subsequently withdrew from the League and the match was classified as a friendly for the purpose of these records.
